



Billing Terms and Charges

Transfer Fee - A charge applied to first bill for all reconnects and transfers on new accounts.

Monthly Base Charge - Offsets service and maintenance costs and exists regardless of usage and activity.

CR - Credit Balance.

E - Estimated Meter Reading. Meter readings are estimated when safe, clear access to the meter is not possible and in member read areas.

Demand Charge - The charge applied for the average peak demand in a 15 minute period on large power accounts.

Conversion Factor (Natural Gas and Propane) - Factor based upon a meter's pressure and altitude.

Multiplier - Converts units measured by a meter for actual billing usage.

Payment Terms and Conditions

Payments are due upon receipt of bill. If payments are not paid prior to the delinquent date, a 1 1/2% per month late payment charge will be assessed.

If a serviceman arrives to disconnect for non-payment, payment in full, plus a \$55.00 Collection Fee and a \$55.00 Reconnect Fee must be collected to continue service. If member requests the service be reconnected after 3pm (Monday through Friday or weekends), a \$190.00 Reconnect Fee will be assessed and paid before reconnection.

NSF Fees - A \$25.00 Handling Charge will be assessed for all returned items. This includes: Returned Checks, Returned Automatic Bank Payments, Returned Credit Card Transactions, or any and all other forms of payment. Payment must be made good, or the service(s) will be subject to disconnection.

Payment Options

Credit Card - We accept Visa, MasterCard, Discover, and American Express for payment of member energy bills. Payment can be made by visiting our website at www.LVEnergy.com or by telephone.

Automatic Withdrawal - The convenience of automatically having a bill paid can be done through automatic payment withdrawal from the member's bank account (a voided check is required) or credit card. Members will still receive a monthly bill so they know how much it is before it is deducted automatically. The date a member's bill is deducted is indicated on the bill and is approximately 20 days from the date billed.

Online Electronic Payment - By visiting our website at www.LVEnergy.com, members can sign up for automatic recurring payments. Members can also view current and past bills online. Posting will show by the next business day.

Paperless Check - We accept paperless withdrawals from your checking or savings accounts.

Levelized Billing - This billing arrangement averages a member's annual energy bill into levelized monthly payments.

Invoice Billing - Combining multiple accounts on a single bill allows members to group multiple accounts. Members can choose which accounts to group together, with the invoice bill reflecting detailed information for each account.

Secure Pay - Pay your bill by phone, 24 hours a day, at your convenience! All payments by phone will need to be made dialing 1-844-206-7875

SmartHub - SmartHub allows you to view your energy usage and pay your bill 24 hours a day using your mobile device. It is available for Apple and Android. Download the App today.
